Online information Collection and Use

We may collect, use, and share the information you provide to us online as indicated under our privacy policy .

Security

We take every precaution to ensure your information remains confidential. The information you provide to us on our Web site is encrypted and protected with an encryption method called Secure Socket Layer (SSL). While on a secure page, the lock icon on the bottom of Web browsers such as Netscape Navigator and Microsoft Internet Explorer becomes locked, as opposed to unlocked or open when you are just 'surfing'.

To send us secure e-mail, you should use our Direct Mail. Regular Internet e-mail is not secure.

Cookies

A cookie is a piece of data stored on the hard drive of your computer containing information about you. Cookies do not contain viruses and most cannot review any of your personally identifiable information unless you willingly provide it as a user on a site.

We use cookies to track and target your interest in order to enhance your online experience with us. Any time a cookie is used, the information is encrypted for our use only and protected from third party access.

Log Files

We use IP addresses to analyze trends and administer the site. IP addresses are not linked to personally identifiable information.
